#### Open Session:

#### Council Discussion:

Council discussed the amount of property that was needed. The attorney suggested the item be tabled until the legal description is provided and the amount needed for a roadway is known. Also the cost of installing the water, sewer and road are unknown at this point in time.

Councilwoman Weight moved the item be tabled pending cost estimates for the water and sewer and road are provided. Motion seconded by Councilwoman Thomas.
