Park Closure:

The clerk recapped an issue that occurred at last year's Early Iron Car Festival. During the car show, the organizer of the event due to overflowing vendors needed additional space. They elected to use part of the skate park and closed the skate park. One or two individuals became upset over the closure and created a scene. To head off a repeat, the organizer requested that the city give them specific authority to close the park.

Councilwoman Hinckley suggested that the park be posted as being closed so the skateboarders would know ahead of time that it was closed.

Authorization for Mayor to execute Dove Ave Water Line Const. Contract

The clerk indicated the bid opening for the Dove Ave water line was set for Friday, August 9, 2013. The next scheduled council meeting is August 20, 2013. On prior contracts, the council has authorized the mayor to execute the contract to the low bid. Being the council will not meet for another two weeks, the clerk recommended the council authorize the mayor to execute the contract prior to the August 20, 2013 council meeting. The time between council meetings would allow the low bid contractor to complete the paper work and allow work to begin on or around September 2, 2013 versus mid-September.

Councilman Simonson questioned what would happen if the bids come in higher than expected. The clerk responded the engineer would need to make his recommendation based on how the bids came out and the number of bidders responding to the bid.

Councilman Zimmermann moved to authorize the mayor to execute the bid to the low bidder based on the engineer's recommendation seconded by Councilman Simonson.

Refund on Park Reservations:

The clerk discussed the code on park reservations which are not refundable. An instance arose where a person made a reservation for a class reunion in early June and then in mid-July cancelled the reservation. The reservation was for an August date. Being the cancellation was made with more than two weeks before the date, the clerk felt a zero refund policy was not equitable and would like to allow for refunds if prior notice is given.

The council discussed that a two week prior to the reservation would be fair to the party making the reservation and allows time for others to reserve the shelter should they cancel.

The mayor directed the clerk to make the changes as discussed and have it available at the next council meeting.

Publish and Hold Public Hearing on 2014 Budget:

The clerk said there were three items that changed since the preliminary budget was discussed at the July 16 meeting. The water department wanted an increase of \$4,000 for leak detection; the police dispatch fees paid to the county came in \$6,000 below the preliminary figure and the 3% allowance in overall property taxes was not included in the preliminary budget.

• The funding for the leak detection was taken from the water fund – discretionary/contingency account with no overall change in revenue nor expenditures.

- The decrease in dispatch fees was added to the general funds discretionary/contingency account with the overall police department expenditures being reduced a like amount.
- The 3% allowance in property taxes (\$33,000) was added to the road fund seal coating expenses.

Aside from the three items mentioned, there were no other changes made. The budget will appear in tomorrow's newspaper as presented before the council this evening. Code requires the budget be published twice with a public hearing being set for August 20, 2013.

Councilman Simonson moved to accept the budget as presented for publication seconded by Councilman Zimmermann.
