## Review and Approval of Bills

The mayor explained a check was needed for the Park/Rodeo concession in the amount of \$6,000 was signed yesterday. The money was needed for change for the upcoming rodeo. If the council disapproved the check the \$6,000 could be withdrawn. Councilman Olsen felt the check should be approved and he supported the park/rodeo 100%.

Councilman Olsen moved to approve the bills along with the park/rodeo check seconded by Councilman Datwyler.

#### **Other Council Business**

- Rodeo Grandstand Ramps: The mayor explained on the new grandstand the ramp and deck had
  holes in the decking material. With the upcoming rodeo the mayor felt the needed existed to
  expend the funds to repair the decking out of the city's discretionary account. The city crew
  replaced the deck at an estimated cost of \$1,200 for material plus labor cost.
- Connections Fees: The mayor had the planning zoning administrator prepare a comparative schedule of the connections fees charged by other cities including Rigby. The report will be made available to the council.
- Library Book Sale: Councilwoman Weight commented that the library was holding a book sale beginning Thursday through Saturday.
- Summer Read Program: Councilwoman Weight also stated the library's summer reading program had begun this week.
- Summer Picnic: Discussion was held on hosting an employee summer picnic sometime this summer. Councilman Burke along with the mayor will coordinate the date.
- Museum Roof: Councilwoman Thomas said she had been brought up to date on the museum roof. The roof which was installed in 1993 is not leaking but has missing shingles along the front of the building. In addition, the exhaust vents from the furnaces are venting under the eaves of the upper roof and causing condensation on the soffits. The project will be considered in the upcoming budget.
- Budgets: The mayor indicated the council will be reviewing the budget during the next two
  council meetings. If they had concerns the council needs to bring them forward or discuss it
  with the appropriate dept. head.
- Parade: The council will be riding on the firetruck with the mayor driving.

#### **Public Comment**

The mayor recognized former city clerk Lloyd Gneiting who was in attendance this evening.

#### **Executive Session**

The mayor indicated there was not anything new concerning the pending litigation and therefore the need for the executive session could be deleted from the agenda.

#### Adjournment

Having no further business, Councilwoman Thomas moved that the council adjourn seconded by Councilwoman Weight.
