City of Rigby Council Meeting Minutes June 2, 2016

Mayor Richardson called the meeting to order at 7:00 pm Thursday, June 2, 2016. The pledge of allegiance was given by Kirk Olsen and the prayer was offered by Doug Burke.

The Mayor asked the clerk to call the roll.

The mayor gave the oath of office to Richard Datwyler.

Election of Council President:

Councilwoman Thomas nominated Councilman Burke as council president, seconded by Councilman Olsen.

Resolution #183-2016 - Signatory Agents for City Investments:

The council passed resolution #183-2016 naming the mayor, council president and city treasurer as the authorized agents on the city cash and investments accounts.

Resolution #181-2016 - Sidewalk Replacement Program:

The mayor reviewed the proposed changes to the city's sidewalk replacement program. The new resolution allows for sidewalks on existing homes and for curb/gutter but deleted driveways approaches. It also sets a fixed dollar for sidewalks and curb/gutter for the city participation.

Consensus among the council was to allow curb/gutter. The amount determined for sidewalks was \$6.00 per square foot and \$13.00 per lineal foot for curb/gutter with after city's 50% participation would be \$3.00 for sidewalks and \$6.50 for curb/gutters.

Councilwoman Weight moved to adopt resolution #181-2016 with the curb/gutter being allowed and the set price for 2016 of \$3.00 for sidewalks and \$6.50 for curb/gutters as the city's portion of the participation. Motion seconded by Councilman Burke.

Treasurer's Review of April 2016 Financial Statements and Journal Entries:

The treasurer reviewed the April 2016 management letter with the council wherein he reviewed the actual revenues to budget along with actual expenditures to budget. Overall he felt the revenues are exceeding budget and expenditures are below budget for most of the funds.

He reviewed the journal entries and explained that beside the recurring and normal entries for the internal service funds and interest earnings he made entries to several funds for contracts approved by the council and encumbered the expenditures for the amount of the contract. Three contracts in the road fund were accrued: seal coating, valley gutters, and chip seal.

The mayor commented that as noted in the treasurer's letter, in the water fund there is savings of \$14,000 over the prior years in power costs. He noted that Ken Harvey has been receiving training on the SCADA system and through his efforts the city is obtaining energy savings.

Review of the City's Personnel Policy:

Councilmen Burke and Olsen reviewed the 1998 personnel policy and using the suggested model obtained from ICRMP insurance updated the policy incorporated the model program with items unique to Rigby.

The council reviewed the policy page by page and made suggestions in the wording and language that needed to be changed and after the changes the policy was to be brought back for additional discussion.

Approve of 2016 Fireworks Permits:
