Idaho Dept. Commerce - Water Project:

Rick Miller from The Development Company came forward and explained the letter the city received from the Idaho Dept. of Commerce. The city was given two options: rescind the application or be placed on stand-by-status for future funding.

Review of Tentative Design of Playground Structures – South Park:

Councilman Burke noted the design for the playground structures was not available at this time. Being such, the item was tabled.

<u>Budget Adjustments – Funds for Playground Equipment:</u>

Being the playground equipment was not being discussed or presented this item deemed tabled.

Treasurer's March 2017 Financial Report:

The treasurer came forward and reviewed with the council the March 2017 management letter he had sent to the council concerning the March 2017 financial statements. He noted that comparatively budget to revenues all funds were in excess of their projected percentages (50%) but for rodeo, airport and water revenue. The rodeo fund has yet to begin their summer activities. The airport fund has a budget of \$20,000 for runway grant funding which has not been received. And the water fund is at 46% of budget however, the summer watering for metered customers has not begun but once they begin watering the revenues will increase.

Comparing expenditures – budget to actual: all of the funds are below 50% but for the debt service fund. This is due to the payment of the \$198,000 bond early in the year with the monthly charges for debt service yet to be billed. All but two funds (rodeo and debt service) have positive excess revenues over expenditures through March 2017.

The various departments within the general fund are at 51% of budget; legal/professional services being at 65% due to the payment of the annual audit fees and annual ICRMP insurance premiums.

He reviewed the March's journal entries he made noting the accrual for property taxes and other quarterly revenues were adjusted at the quarter which is not normally done only at the end of the quarter.

Transfer to Airport:

He noted last year the city was late in transferring the budgeted amount for the airport expansion until the end of September which caused confusion for the auditor. To avoid confusion this year he requested the council approve the budgeted transfer of \$20,000 from the general fund to the airport.

Councilman Taylor moved that the transfer of \$20,000 from the general fund to the airport be approved, seconded by Councilwoman Thomas.
