Treasurer's Aug '17 Financial Report:

SCADA Upgrade of System:

The public works director came forward with a recommendation to upgrade the current SCADA water monitoring system. The cost of the upgrade is \$8,835.

- <u>Fiber Optic -</u> Councilman Burke updated the council on the meeting held Thursday at Ammon city offices on their implementation of the fiber optics networking. Council was interested in looking into the concept and would like to have Ammon's technology director, Bruce Patterson discus the concept in more depth with the council at a later date.
- <u>Solar Lighting of Rigby's Highway Signs:</u> The mayor distributed a proposal from TOTAL SOLAR to install solar lighting on the entrance signs on the north and south side of Hwy 20. The proposal is \$1,987 per sign. Council discussed the item and asked if the price included installation. It will be moved to a later agenda item this year.

Bo Porter came forward and questioned the proposal regarding the amend plat for Rigby Towne Square. He felt the lines shown as amending the plat was incorrect and needed further explanation. The mayor indicated he would look into it.
