#### Other Council Business:

<u>Urban Renewal:</u> Councilman Burke reviewed the meeting he had with the urban renewal concerning the highway sign and the splash park. On the <u>highway sign</u> it was learned that the sign cannot have advertising on the sign being that it is not on private property. The selling of advertising on the sign was thought to offset the cost of operation of the sign. More information on this restriction/limitation will be obtained at a later date.

Splash Park: After the discussion at last council meeting the urban renewal is looking at putting the splash park on hold for a year or two. Instead they are looking at upgrading the playground equipment in the south park. They also discussed removing all of the old equipment and relocating it to the Pioneer Park (located west of North 4<sup>th</sup> West in the Pioneer Park subdivision). They are looking at installing a "giant" super play structure costing around \$140,000

<u>Cordon Home</u>: Councilman Olsen asked if the agency was looking at purchasing the Cordon home. The mayor said the property owner was wanting more for the home and property than what the agency was willing to pay.

<u>Planning/Zoning:</u> Councilman Datwyler asked if the two planning/zoning hearing's information had been forwarded to the council. The mayor indicated it would be on the next agenda.

<u>Public Comment</u>: Councilman Taylor asked if there needed to public comment. The mayor indicated he left that item off the agenda given the next agenda item. Councilman Taylor asked the one individual in the room if he had any comment, he indicated no.

## Executive Session:

Councilman Taylor moved that the council enter into executive session per Idaho Code 74-206(a) – to consider the hiring a public officer wherein the respective qualities of individuals are to be evaluated in order to fill a particular vacancy. Motion seconded by Councilwoman Thomas.
