Extension of Water Line Engineer Contract:

Mr. Bradley wanted to get the water line prior to the school/county widening 200 North for the new school. If the road were to be widened prior to the installation of the water line the city would have to repave part of the asphalt. If the line were installed before the road is widened, the city only needs to backfill and compact the road surface being it lacks asphalt.
